RULES / LOCAL RULES

Play is governed by the current USGA Rules of Golf and the WOSGA Conditions of Competition and Local Rules.

FORMAT

36 holes of individual stroke play. Tee times on Monday will begin at 8:00 a.m. and Shotgun start on Tuesday will start at 9:00 a.m.

FLIGHTS – Flights shall be determined by handicap and DOB for Super Seniors.

AUTOMOTIVE TRANSPORTATION

Automotive transportation is required. The player is prohibited from using a caddy or carrying their bag during the stipulated round.

REGISTRATION

Registration will be at the first tee. Please check in with the starter at least 20 minutes and no more than 40 minutes before your tee time. Scorecards and additions to this information will be distributed at the first tee.

PRACTICE

Practice facilities will open at 7:00 a.m.

BAG STORAGE

Bag storage is included in the entry fee and is required on Monday night to help club staff set up for Tuesday's shotgun start.

HOLE LOCATIONS

Hole location sheets will be provided. Distance measuring devices may be used during this event, but measurement of elevation/slope/wind must be disabled. (Rule 4.3a)

PACE OF PLAY

See WOSGA Pace of Play policy on our web site

STARTING AREA

Tent near the 1st tee

SCORING

Players are encouraged, but not required to enter scores into the Golf Genius app.

At the completion of play, please report to the scorer's table located in front of the Pro Shop.

LOCAL RULES

PENALTY AREAS – Defined by yellow stakes and lines and red stakes and lines. Ground under repair defined by white lines. Any staked trees and/or newly sodded areas are also considered GUR.

- Hole #8 the area behind the green is a Red Penalty Area. Play from this area is prohibited. The fence behind the green is inside the margin of the penalty area and is an integral part of the golf course. Relief from the fence is prohibited by the Rules of Golf.
- No mow zones, although not marked with red lines/stakes, are Red Penalty Areas.

OUT OF BOUNDS – Defined by white stakes and boundary fences

DROP AREAS

- Hole #7 located just short of the creek near the cart path.
- Hole #8 to be used ONLY if ball crosses the line along the fence line behind the green. Located to the left and slightly behind the green.

IMMOVABLE OBSTRUCTIONS

Free relief from all stone-edged landscaped areas

SUSPENSION OF PLAY

A suspension for a dangerous situation will be signaled by one prolonged siren blast. Suspend play immediately and seek shelter.

DOUBT AS TO PROCEDURE

If there is doubt as to procedure and no rules official can be summoned in a reasonable time, the player should play two balls and report the score from both balls at the scoring table upon completion of play. (Rule 20.1c(3)).

FOOD and BEVERAGE

Water, iced tea, and lemonade will be provided at the clubhouse. Additional food and beverage may be purchased with cash or credit card. There will be no charge back.

- Dinner (included in your entry) on Monday evening begins with cocktails at 6:00 p.m. (cash bar) and dinner at 7:00 p.m. The dinner includes the Betty Kerby Peppard Award Presentation.
- Lunch (included in your entry) will be served and prizes awarded at the conclusion of play on Tuesday.

TIES

In case of a tie for the lowest score for the championship, the winner shall be determined immediately by a sudden-death playoff. All other ties are broken by comparison of the scorecard. Determining the winner will be based on the score for the last nine holes, last six holes, last three, holes and finally the 18th hole. If there is still a tie, then the last six holes, three holes, and the final hole of the first nine holes will be considered in turn. If this process does not result in a winner, the winner will be chosen by chance (such as tossing a coin). If a multi-tee start is used, then the last nine holes, last six holes, etc., are holes 10-18, 13-18, etc. If the round is less than 18 holes, the number of holes used in matching scores may be adjusted. For weather-shortened events, the total number of holes played may be modified.
